My name is Maram Hamissa and I am a Journal Developer for the Hindawi Publishing Corporation. I am writing to invite you to join the Editorial Board of The Scientific World Journal as part of the journal's High Energy Physics subject area. The Scientific World Journal is a peer-reviewed, open access journal covering a wide range of subjects in science, technology, and medicine. The journal has been published since 2000, and it currently has an Impact Factor of 1.524.

Hindawi has taken over the publication of The Scientific World Journal, and we are currently in the process of expanding its Editorial Board. If the majority of the editorial evaluations that are received by the end of this second round of review recommend the manuscript be accepted for publication, the manuscript will be accepted. Otherwise, the manuscript will be rejected. If the manuscript is accepted for publication, the names of the Editors who recommended the publication of the manuscript will be published alongside the manuscript. The journal will be published using an open access model, which allows disseminating scholarly articles by removing the access barriers imposed by the subscription model, in order to make the full-text of all published articles freely available for any interested reader. In this model the publication costs of an article are covered in the form of Article Processing Charges, which are publication fees paid from the research budget of accepted authors. In this model authors retain the copyright of their work, and we make every possible effort to ensure that the full-text of every published article is both visible and accessible to all potential readers.

Manuscripts that are submitted by the members of the Editorial Board of The Scientific World Journal to the journal will automatically receive a 50% reduction in their Article Processing Charges.
